Buyer agrees that by placing one or more bids on the property and by being the high bid on the property at the end of the auction, they shall agree to sign the Land Mark Management & Realty, Inc. real estate purchase agreement in person or electronically and provide to the Broker the required earnest deposit to be deposited into the Land Mark Management & Realty, Inc. Real Estate Trust Account.
